### **Minnesota Department of Human Services (DHS)**

You have the right to file a complaint with DHS if you believe you have been discriminated against in our health care programs because of any of the following:

- race
- color
- national origin
- creed
- religion
- sexual orientation
- public assistance status
- age
- disability (including physical or mental impairment)
- sex (including sex stereotypes and gender identity)
- marital status
- political beliefs
- medical condition
- health status
- receipt of health care services
- claims experience
- medical history
- genetic information

Complaints must be in writing and filed within 180 days of the date you discovered the alleged discrimination. The complaint must contain your name and address and describe the discrimination you are complaining about. After we get your complaint, we will review it and notify you in writing about whether we have authority to investigate. If we do, we will investigate the complaint.

DHS will notify you in writing of the investigation's outcome. You have the right to appeal the outcome if you disagree with the decision. To appeal, you must send a written request to have DHS review the investigation outcome. Be brief and state why you disagree with the decision. Include additional information you think is important.

If you file a complaint in this way, the people who work for the agency named in the complaint cannot retaliate against you. This means they cannot punish you in any way for filing a complaint. Filing a complaint in this way does not stop you from seeking out other legal or administrative actions.

# Program Descriptions and Introduction

---

## Program Descriptions

### Families and Children:

Families and Children is a managed care program that covers health care for the following people who have Medical Assistance:

- Children under the age of 21
- Parents and caretakers of a dependent child
- Pregnant women
- Low-income adults without a dependent child

### MinnesotaCare:

MinnesotaCare is a managed care program that covers health care for people who do not have access to affordable health care coverage. Some members may be required to pay a premium to the State.

**Minnesota Senior Care Plus (MSC+):** MSC+ is a managed care program that covers health care and Elderly Waiver services for people who:

- are age 65 and over and
- have Medical Assistance.

If you are enrolled in MSC+, you may have another option. Check with your county financial worker to see if you can enroll in the Minnesota Senior Health Options (MSHO) program. MSHO is a voluntary program.

## Introduction

### How do you find IMCare Providers in your area?

Providers in this directory are divided into sections by type (for example, *primary care providers, hospitals, dental providers, etc*). Locate the type of provider you are looking for in the table of contents and go to that section in the directory. Provider types are listed alphabetically by location.

### Network Providers

You must get all your health care from IMCare network providers. There are some exceptions. Examples of exceptions are emergency or urgent care, open access services and other previously authorized services. If you have questions about the providers you should use, please contact Member Services.

### Specialty Providers

A specialist is a health care provider who provides treatments for specific diseases or part of the body. There are many different kinds of specialists. A few examples of specialty providers are:

- Oncologist, who care for patients with cancer
- Cardiologists, who care for patients with heart conditions
- Orthopaedics, who care for patients with certain bone, joint, or muscle conditions

When your primary care provider thinks that you need specialized treatment, you may go to see a specialist within our network without a referral. If you need services from a specialty provider and they are not listed in this directory, you will need to contact your primary care provider for a referral. You can get more information on how to access specialists by calling Member Services at the phone number at 1-800-843-9536 (toll free) or 218-327-6188. TTY users call 1-800-627-3529.



## Emergency Care Access

**In an emergency that needs treatment right away, either call 911 or go to the nearest emergency room.** Call for an ambulance if you need it. You do not need to get approval or a referral from your primary care provider. You may get emergency medical care whenever you need it, anywhere in the United States or its territories. IMCare covers ambulance services in situations where getting to the emergency room in any other way could endanger your health.

## Home and Community Based Services (HCBS) and *\*Personal Care Providers (PCA's)\* MSC+ Members Only*

The following providers are not listed in this directory, Home Care Agencies, Home and Community Based Service (HCBS) providers, and Personal Care Provider Agencies. IMCare uses the DHS Open Network for these providers. For a list of Elderly Waiver services and providers available for Tier 1 Services and Tier 2 Services, go to the Minnesota Help Info Website at <http://www.minnesotahelp.info/public/>. ## Long Term Services and Support (LTSS) (MSC+ members only)

You may be able to get long-term services and support (LTSS), such as services provided by the Elderly Waiver (EW) program as an IMCare member. Long term services and supports are help for people who need assistance to do everyday tasks like taking a bath, getting dressed, making food and taking medicine. Most of these services are provided at your home or in your community but could be provided in a nursing home or hospital. To find out more about these services, see your Member Handbook. Call Member Services to get more information on how to access these services.

# Important Information

---

## Care Coordination

IMCare's care coordinators help connect members to services and resources they need to get the best possible care. Some members are also eligible for case management through the county. County case managers/care coordinators may be nurses or social workers. They coordinate health care services for members and can accompany members to health care appointments, if needed. They can also assist member with the following:

- Arranging for and coordinating assessments, tests, and other health and continuing care services
- Developing and updating member care plans
- Communicating with a variety of agencies and people
- Disease management programs
- Other services as outlined in member care plans

Members have the right to refuse case management/care coordination services. You can get more information on how to access care coordination by calling Member Services at 218-327-6188, Toll Free 1-800-843-9536, TTY 1-800-627-3529 or 711.

## Clinics

When you are a member or become a member of IMCare you chose or were assigned to a primary care clinic. Your primary care clinic can provide most of the health care services you need and will help coordinate your care. You may change your primary care clinic by calling Member Services at 218-327-6188, Toll Free 1-800-843-9536, TTY 1-800-627-3529 or 711.

## Cost Sharing

You may be required to pay an amount toward some health care services. This is called cost sharing. Some examples of cost sharing are copays or deductibles for certain services. You are responsible to pay your cost sharing amount directly to your pharmacy or healthcare provider. Members get a Member Handbook with

more information about cost sharing.

### **Member Handbook**

To get detailed information about covered health care services, see your Member Handbook. It also explains your rights and responsibilities as a member of IMCare. Contact Member Services at 218-327-6188, Toll Free 1-800-843-9536, TTY 1-800-627-3529 or 711. You can ask for a printed copy of the Member Handbook at any time. You can contact Member Services to request a printed copy or visit [www.imcare.org](http://www.imcare.org) to access it electronically.

### **Interpreter Services**

American Sign Language (ASL) and language interpreter services are available to help you get services. Oral interpretation can be given to you in your language. You may be able to get written information in your language, call Member Services to get more information on interpreter services.

### **Member Identification (ID) Cards**

Members get a health plan member identification (ID) card. You must show this card whenever you get health care services, including when you get a prescription filled. You will get your member ID card with your member packet when you become our member. You may request a replacement ID card or a Member Handbook by calling Member Services at 1-800-843-9536 (toll free) or 218-327-6188. TTY users call 1-800-627-3529 or 711 (toll free).

### **Service Accessibility**

If you need special access to get services from a provider, you can get information by calling Member Services at 1-800-843-9536 (toll Free) or 218-327-6188. TTY users call 1-800-627-3529 or 711 (toll free). Or visit [www.imcare.org](http://www.imcare.org). This could include, but is not limited to, access for services such as accessible office, exam room and equipment.

### **Prior Authorization**

Our approval is needed for some services to be covered. You must get our approval before you get certain services or before we pay for them.

Members need a prior authorization to see any provider who is NOT part of IMCare's network, except for emergency and urgent care services, renal dialysis and open access services. Members get a Member Handbook with more information about which services require prior authorization.

# Services

---

## **Behavioral Health**

Behavioral health services include care and treatment for depression, anxiety or other behavioral health issues that interfere with your daily functioning.

## **Elderly Waiver Home and Community Based Services for MSC+ members**

If you are age 65 or over and need help to stay in your home, a program called Elderly Waiver (EW) can help. EW offers more services than regular Medical Assistance. Services may include visits by a nurse, home care services, homemaker services, chore services, and more. Your care coordinator or case manager can arrange these services for you. If you want more information, please call Member Services at 1-800-843-9536 (toll free) or 218-327-6188. TTY users call 1-800-627-3529 (toll free) or 711.

## **Elderly Waiver Obligation for MSC+ members**

If you get EW services and your income is over the income limit, you may have to pay a monthly amount. This is called the EW waiver obligation. Your county will tell you about any EW waiver obligation when your eligibility is determined.

## **Home Care**

Home Care services include the following:

- Skilled nursing
- Rehabilitation therapies (for example: speech, physical, respiratory, and occupational)
- Home health aide
- Medical equipment and supplies
- Personal Care Assistant (PCA), *MSC+ Only*
- Home Care Nursing (HCN) services, *MSC+ only*

*Families and Children and MinnesotaCare:* Members can get information on how to access Personal Care Assistant (PCA) services by calling Itasca County intake for long term care services and supports.

*MSC + Members:* IMCare Members can get information on how to access Personal Care Assistant (PCA) and Home Care Nursing (HCS) services by calling Member Services at 1-800-843-9536 (toll free) or 218-327-6188. TTY users call 1-800-627-3529 (toll free) or 711.

## **Medical Equipment and Supplies**

Medical Equipment and Supplies is any medical equipment you can use in the home to improve your quality of living. It can also provide therapeutic benefits to people with certain medical conditions or illnesses. Examples are nebulizers, wheelchairs, crutches and many others. You can get information on how to access Medical Equipment and Supplies by calling Member Services at 1-800-843-9536 (toll free) or 218-327-6188. TTY users call 1-800-627-3529 (toll free) or 711.

## **Nursing Home and Skilled Nursing Home Care for MSC+ Members**

For MSC+ members, we will cover a total of 180 days of nursing home care. If you need nursing home care for more than 180 days, DHS will pay for your care. This applies unless you were already in the nursing home when you joined our plan.

### **Open Access Services**

For some services, you may choose to get care from any health care provider, clinic, hospital, pharmacy, or family planning agency even if the service/provider is not in our network.

These are called “**open access services**” and include the following:

- Family planning
- Diagnosis of infertility
- Testing and treatment of sexually transmitted diseases
- Testing for AIDS or HIV-related conditions

### **Pharmacy**

Members must use our network of pharmacies for drugs covered by our health plan except under non-routine circumstances when you cannot reasonably use network pharmacies. Remember to have the following available when you call to refill your prescription:

- IMCare Member Identification (ID) Card
- Minnesota Health Care Programs card
- Cards for any other health coverage you have, such as Medicare Part D or private Insurance.

It is important to remember to show both your Member Identification (ID) card and your Minnesota Health Care Programs card when picking up your prescriptions.

To see the IMCare drug formulary, go to [www.imcare.org/386/Members](http://www.imcare.org/386/Members) and look in the Member Documents box.

People with Medicare must enroll in a Medicare Prescription Drug Program (Medicare Part D) to get most of their drugs.

### **Substance Use Disorder**

Substance use disorder (SUD) services provide care and treatment for substance use disorders.

Substance use disorders can include abuse of alcohol, narcotics, or other drugs. Call

Member/Customer Services at 1-800-843-9536 (toll free) or 218-327-6188 for more information on substance use disorder screening options. TTY users call 1-800-627-3529 (toll free) or 711 options.

### **Transition of Care**

When you join IMCare we will help you continue to get necessary health care services that were authorized before you joined our plan. Some examples are the following:

- Behavioral health services
- Orthodontia
- Prescriptions
- Services for at-risk pregnancy
- Substance use disorder services

If you are currently getting care from a provider who is not in our provider network, we will help you transition to a participating provider. If you would like more information, please contact Member Services at 1-800-843-9536 (toll free) or 218-327-6188. TTY users call 1-800-627-3529 (toll free) or 711.

## Transportation for Families and Children and MSC+ Members

Transportation is available for MinnesotaCare children under age 19.

We are not required to provide transportation to your primary care clinic if it is over 30 miles from your home, if another primary care clinic is available within 30 miles. Exceptions to this rule can be made in certain circumstances. If you need a ride and there is not a closer clinic in our network area, please call the transportation number for Itasca County at 218-327-6747.

If you need help finding special transportation, Member Services at 1-800-843-9536 (toll free) or 218-327-6188. TTY users call 1-800-627-3529 (toll free) or 711. Special transportation includes things like handicapped accessible vehicles or ambulances. Members will get access to a Member Handbook with more information about transportation.

## Urgent/After Hours/Emergency Care

Call your primary care clinic if you need medical care during clinic hours. When your primary care clinic is closed you may call your local hospital. There will always be a health care provider on call who can tell you how to arrange for care. **In an emergency that needs treatment right away, either call 911 or go to the nearest emergency room.**

## To Make Your Search Easier

---

Information about the following is included in the provider listings:

- Most facilities are accepting new patients, unless noted **\*\*\*Not accepting new patients.**
- *Cultural Comp. Training* means providers have completed cultural competency training in the last 12 months. Cultural competency training, as defined by the Centers for Medicare and Medicaid Services (CMS), is additional instructions for our health care providers that helps them better understand your background, values and beliefs to adapt services to meet your social, cultural and language needs. If Cultural Competency Training is not noted under a provider, IMCare has not received indication that they have completed the training.
- *ADA Compliant Office.* Accessibility of the provider's office, exam rooms, and/or equipment. For more information about specific accessibility needs, call your provider. The Americans with Disabilities Act (ADA) requires that people with disabilities have equal access to services.
- Languages spoken at the facility.
- Hospital affiliations for primary care clinics.
