Know All Men By These Presents:

That I, Thos. Erskine, as county Auditor in and for the County of Itasca, and State of Minnesota, have been such Auditor at all times herein mentioned; that the following described Tracts or Lots of Land, to-wit: Section 28, Township 54 North, Range 23 West of the Fourth Principal Meridian, in Itasca County, Minnesota, is divided into parcels of irregular shape, which cannot be described except by metes and bounds, that on the 1st day of February, 1933, I as said Auditor, duly requested the owners of said tracts of land, to-wit.
