The above-named applicant hereby requests that the designated private driveway located on the above-described tract of land be graded by Itasca County. Agreement to provide grading service shall be subject to all the provisions following:

GENERAL PROVISIONS

1. County grading will be performed only on those driveways outside the municipal limits.
2. County grading shall be done on private roadways only as equipment and manpower are available.
3. Separate applications must be made for each requested grading.
4. The County will grade private driveways only when grading in the area.

SPECIAL PROVISIONS REGARDING DRIVEWAY

1. Driveway must be clear of obstructions at least 10 feet on either side of its centerline with adequate turnaround.
2. All applicants for grading service will have their private driveways clearly marked to indicate ownership, either by displaying their emergency number or their name on their mail box or in some other way.
3. Gates or barricades must be open to allow unimpeded ingress and egress of grading units.

RATES

1. Regular grading rates shall be \$100.00 per hour, *\$50.00 minimum for each trip.*
2. Payment for grading services must be made within thirty (30) days of date of invoice.
3. A late fee of \$10.00 will be added to your statement if it is not paid by this date and no contract work will be done in your driveway until all past-due charges are paid in full.

I hereby declare that I am the owner/renter of the above described property and take full responsibility for grading charges. Further, I hereby WAIVE ANY AND ALL CLAIMS FOR DAMAGES TO MY PROPERTY, BOTH REAL AND PERSONAL, WHICH MAY BE CAUSED BY THE COUNTY OF ITASCA, ITS EQUIPMENT, OR ITS EMPLOYEES WHILE GRADING MY ROADWAY.

FURTHER, IN CONSIDERATION OF THIS AGREEMENT AND OTHER GOOD AND VALUABLE CONSIDERATION, I AGREE TO INDEMNIFY ITASCA COUNTY FROM ANY AND ALL LOSSES OR DAMAGES ITASCA COUNTY MAY SUFFER AS A RESULT OF CLAIMS OR JUDGEMENTS AGAINST IT FROM ALL PERSONS WHATSOEVER ARISING OUT OF THE DESIGNATED GRADING SERVICES.
